About our Facility:

La Crosse County Fairgrounds is home to a beautiful horse barn constructed in 2008. We have indoor stalls for over 100 horses. The show will be held in our indoor arena. We have a nice outdoor arena and lunging arena for your use, too. On-grounds camping is available. There will be vendors and great food.

Location:

La Crosse Interstate Fairgrounds is located in West Salem, Wisconsin. West Salem is just 12 miles East of La Crosse, on I90 exit #12. The fairgrounds are easily accessible from both the Interstate and US Hwy 16. Driving directions: **From I-90 westbound**, take Exit 12 (West Salem). Go south to 3-way intersection, turn right (west) on County Road C. Go 1.3 miles, turn right (north) at 3-way intersection onto County Hwy M. Fairgrounds are about 1 mile ahead, on the left, just past the stoplight. **From I-90 eastbound**, take Exit 5 (Onalaska). Turn left (east) on Hwy 16 and drive 4.5 miles to West Salem. At stoplight, turn left, go 1/4 mile and the Fairgrounds are on your left.

Accommodations:

Camping is available on the grounds for a \$35 fee, purchased in the Show Office upon arrival. Other campgrounds in the immediate area are Neshonoc Campground and Veterans Memorial Campground. Within one mile of the fairgrounds is the AmericInn Motel of West Salem, which allows pets. Hundreds of motel rooms are available within five miles of the grounds West on I-90, such as Holiday Inn Express, Microtel Inn, Baymont Inn, Hampton Inn and Stoney Creek Inn, Onalaska or in Sparta, Country Inn & Suites.

4-H Champ Show Guidelines

GENERAL GUIDELINES:

1. You must have received either a 1st or a 2nd in a qualifying class (see Champ Show class list attached) at your 2019 county fair in order to qualify for the Champ Show. You must use the same horse(s) with which you received your 1st or 2nd. You may not substitute a horse for ANY reason. If you qualify with two animals, you are welcome to show both. Please fill out two registration forms to eliminate confusion. Registration form must be signed your county extension agent to verify eligibility. Your school grade is of 1/1/19.
2. Registration forms and fees must be received by **August 24, 2019**. No registrations will be accepted on show day.
3. Only members of the immediate family, and a 4-H youth paired with a Horseless Horse youth, are permitted to show the same project animal. Each family member may show any combination of classes, provided the horse is only shown once in a specific class number.
4. A junior horse, 5 years old and under, may be shown in a bosal or snaffle.
5. Horses may be ridden only by exhibitors. Parents, trainers, friends are not permitted to ride. This rule will be enforced. Special permission for lunging assistance for safety reasons may be obtained by reporting the circumstances to the show office. A special permit **MUST BE WORN** while handling the animal.
6. SEI approved helmets with safety harness securely fastened must be worn whenever mounted or driving a horse. Appropriate riding boots must be worn—no tennis shoes, flip flops, etc. This includes warm ups.
7. All exhibitors will be issued an exhibitor number which must be worn on their back or the number may be used on BOTH sides of the saddle pad.
8. Original, current negative Coggins required prior to unloading your horse. The Barn Coordinator will check your horse in and provide you with your stall assignment.
9. No horses will be allowed to tie overnight to trailers.
10. Exhibitors less than 18 years old must be accompanied by a parent or guardian while on the grounds.
11. Any exhibitor using alcoholic beverages or illegal drugs, or who demonstrates inappropriate behavior while on the show grounds, will be required to leave the grounds at the discretion of the Show Committee.
12. A typical lunch stand will not be available. There will be a Chicken-Que on site. Tickets can be pre-purchased for \$10.00 each. A limited number of tickets will be available day of show.
13. Dogs must be on leashes at all times.
14. Refunds of show entry fees is reserved for emergency and veterinary reasons. Please contact 4-H Champ Show Chair to get approval from the committee.
15. The show committee reserves the right to combine classes based on entry numbers.

SHOW OFFICE:

1. Show office, located in the Small Animal Barn, will be open from 6:00 – 9:00 p.m., Friday night, and at least one hour prior to the start of the show on Saturday.
2. Participants will receive their exhibitor number from the show office.

SHOW RULES:

1. The La Crosse County 4-H Champ Show will be governed by the rules and guidelines of the State 4-H Horse Show. Refer to these guidelines for descriptions of proper tack and attire. PONY EXHIBITORS:

1. Ponies may enter only classes designated as a pony class. (NOTE: Once you have entered a pony division you must remain in the pony division for the entire show.) Ponies include heights of 56" and under. Any equine over 56" will be considered a horse. All equine entered in a pony class must be measured before exhibitor number is issued.
2. Pony measurement available Friday, 6:00-8:00 p.m. and Saturday, 7:00-8:00 a.m.



ARENA RULES:

1. SEI approved helmets must be worn while riding and driving with chin straps fastened.
2. Boots must be worn while riding.
3. No lunging of horses in the main arena. An outdoor lunging area is provided in addition to the outdoor arena.
4. No bareback riding or riding double.
5. No tying in the arena.
6. The arena will be open for practice riding Friday evening, from 5:00p.m. – 10:00 p.m. and from 5:00 a.m-7:30a.m. Saturday.
7. Respect other participants.
8. If a horse is presenting a danger to its rider or other exhibitors, that horse and rider may be asked to leave the ring by show management.

STALLS:

1. Stalls will be assigned by Show Barn Coordinator. You may not switch stalls.
2. Please bring your own bedding.
3. Stall fees cover one- or two-nights use. (Friday and/or Saturday)
4. Emergency information stall card must be completed and affixed to stall.
5. A master stall list will be posted in the Show Office.
6. A stall fee of \$20 must accompany your registration form, together with a separate check in the amount of \$20 as your stall cleaning deposit.
7. When you leave, you must clean your own stall. A limited number of wheelbarrows, shovels and picks will be available. The Barn Coordinator will inspect your stall and return your \$20 deposit. If your stall is not cleaned, then the cleaning deposit will be forfeited by you. Checks will not be mailed, you must pick them up upon leaving or you will forfeit your deposit.
8. Tack stalls MAY be available for \$20 each. Check with Barn Coordinator upon arrival.

OVERNIGHT CAMPING:

1. Overnight camping, with electrical hookup, is available on the show grounds. Campers, tents, trailers are allowed. Bathrooms are available.
2. A weekend camping fee of \$35 will be collected in the show office (or you can send in with registration) and permit will be issued.

SEI approved safety helmets (with safety harness securely fastened), boots with cut out heel, and exhibitor number must be worn on your back.

GENERAL GYMKHANA RULES:

1. Safety is of utmost importance.
2. All classes will be run with a closed gate.
3. Horses MAY NOT run outside of designated show or practice areas. Failure to comply may result in disqualification and/or removal from show.
4. No reruns are permitted for equipment failure.
5. In the event of a tie, the contestant declared the winner in the run off must rerun the pattern within two (2) seconds of his original time or the runoff must be held again.
6. Any rider that the show committee or judge considers to be exhibiting unduly severe or unsafe practices, or using equipment in a severe or unsafe manner, may be disqualified.
7. Any exhibitor displaying unsportsmanlike conduct (including improper language) may be disqualified.
8. A judge(s) designated by the show committee will be at the arena and observing while the gymkhana event is being run. One of these will be designated as the official judge and will have the final say in interpretation of the gymkhana rules.
9. Each contestant will be called three (3) times by name/number (in the hole, on deck, up). The contestant will have 30 seconds to enter the arena after the last call. Contestants must start their run within 30 seconds after entering the arena.
10. No handlers, to help contestant, are permitted in the arena unless there is an emergency situation.
11. The barrels should be 55 gallon plastic drums. If metal, they should have padded tops.
12. All other state 4-H Gymkhana rules will be enforced.
13. Decisions will be determined by show committee.
